## Pro Bono Opportunity: Help an Elderly Woman Protect Her Family's Property and Prepare Estate Planning Documents

**Case Description:** Ms. S is an 80-year-old woman whose husband died in 2019. She has four sons and several grandchildren. Ms. S and her husband owned a house as community property. She has a healthcare power of attorney, but it names her deceased husband as agent. Ms. S would like to create a will or trust to protect her property and secure her family's financial future.

**Work Required & Deadlines:** (1) Transfer the title of the house to Ms. S' name (can be transferred without administration). (2) Prepare estate planning documents for Ms. S.
