


Dear Friends,

**Happy Hispanic Heritage Month!** Celebrations run from September 15th through October 15th. HHM's unique start date coincides with the celebrations of independence of several Latin American countries, including Costa Rica, El Salvador, Guatemala, Honduras, and Nicaragua. Also, during the month of September, Mexico and Chile declared independence from Spain, and Belize from Great Britain.



**Even as we celebrate, SCOTUS has recently lifted a restriction on ICE targeting L.A. residents based on racial profiling issued by a lower court.** The Court's decision to intervene early and without articulating any legal reasoning makes all Angelenos, regardless of their immigration status, less safe by subjecting our communities to terror disguised as "law and order."

**The intervention subjects individuals to further profiling, harassment, and illegal detention.** It makes all Angelenos unsafe because while today this decision most directly impacts those profiled as immigrants, tomorrow the reasoning could be applied to anyone targeted by the federal administration.

Bet Tzedek stands by the idea that our nation reaches its highest ideals when every person feels safe, regardless of the color of their skin or where they are from. We remain steadfast and committed to reaching every client, recognizing the dignity of their humanity through service.



1. Prepare for immigration enforcement encounters with what to do and say

## What We're Reading: "Solito" by Javier Zamora

*Solito* is a deeply moving memoir by Salvadoran poet Javier Zamora that recounts his harrowing 3,000-mile journey from El Salvador to the United States at the age of nine. The book is narrated in the first-person present tense, capturing the immediacy and emotional intensity of a child's experience as he travels unaccompanied to reunite with his parents in California. The memoir is not only a personal story of survival and resilience but also a powerful testament to the emotional toll of migration on children. Zamora's poetic language and childlike perspective illuminate the trauma, fear, and hope that define the migrant experience.

Javier Zamora's journey in *Solito* mirrors the lived experiences of many undocumented children who arrive in the U.S. alone or without legal status. **Bet Tzedek plays a critical role in supporting these youth by helping them apply for Special Immigrant Juvenile Status (SJS).** This form of immigration relief available to children who have been abused, abandoned, or neglected by one or both parents—Bet Tzedek's work ensures that undocumented minors like Javier—who might otherwise fall into the foster care system or face deportation—can access legal guardianship, remain safely in the U.S., and thrive.
