Bet Tzedek acknowledges that the County of Los Angeles occupies land originally and still inhabited and cared for by the Tongva, Tataviam, Serrano, Kizh, and Chumash Peoples. The Tongva People have lived in Tovangar — the 4,000+ square mile region

now known as the Greater Los Angeles Basin — for at least 10,000 years.

Injustices endured by Indigenous communities — through broken treaties, land dispossession, forced displacement, and countless other harms — reflect broader patterns of systemic oppression that continue to shape inequities today. However, today's Native Americans in Los Angeles are a vibrant, resilient community with new hubs, youth engagement, community events, and cultural preservation.
